The dealer shall be entitled to make a mark-up on the sale of the product, which mark-up shall be in accordance with the AcornKids Dealer Manual. The Company grants the dealer the right to purchase and resell the Companies products throughout the region of the Republic of South Africa. Products supplied by Acorn Africa may not be exported outside of the Republic of South Africa by the dealer.
- The dealer acknowledges that he/she is an independent dealer and that no employment relationship will come into existence between the Company and the Dealer, and that the dealer shall not be recognised as an agent of the Company, or of his/her sponsor. As an independent dealer, Acornkids does not deduct personal income tax and the dealer is responsible for complying with his/her obligations in terms of personal income tax.
- The dealer agrees to abide by the policies and terms of conduct of AcornKids, as described in the AcornKids Dealer Manual, as updated or amended from time to time. The dealer agrees to receive email and sms marketing information from Acornkids as long as she/he remains an Acornkids dealer.
- This Agreement shall commence on the date of payment of the registration fee, and continue for an indefinite period unless terminated. No annual membership fees are payable. For the Agreement to remain valid the dealer must make at least one purchase per quarter (Jan-Mar, Apr-Jun, Jul-Sep, Oct-Dec). Failure to do so will result in termination of the Agreement. In addition, either party may terminate this Agreement at any stage by written notice to the other party, without providing reason.
- The dealer shall at all times act in good faith and conduct his/her business in a manner that ensures that the good name and reputation of AcornKids is maintained at all times. The dealer confirms that he/she is over 18 years of age.
- The dealer has 30 days to cancel the agreement if desired, which must be done in writing. In this period the dealer may return the Business Kit and any other products, in original undamaged condition, and receive a full refund, excluding freight costs.
